2018: Another record breaking year for European tech exits...

€107Bn of exits (sale or IPO) of European venture backed companies.

Four €5Bn+ large IPOs:





...first time Europe close to the US with \$107Bn of exits vs. \$136Bn in the US and \$113Bn in China.





European VC financing still behind US and China both in absolute terms and relative to GDP at 0.13% vs. c.0.50% in US and China...



...although growing faster than the US, it is from a lower base. More than 2x slower than China at c.30% 6yr CAGR vs c.70%.
