

# MCI Capital TFI begins public issue of series M certificates

MCI Capital TFI SA offers individual investors the possibility to invest in investment certificates of the MCI TechVentures subfund, which through focusing its investments on advanced technology companies realized historically above-average returns: over 40% last year and over 148%\* during the last three years.
